Instructions for Payer/Borrower

- **Box 8.** This is the address or description of the property securing the mortgage.
- **Box 9.** If more than one property secures the loan, shows the number of properties securing the mortgage. If only one property secures the loan, this box may be blank.
- **Box 10.** The interest recipient may use this box to give you other information, such as real estate taxes or insurance paid from escrow.
- **Box 11.** If the recipient/lender acquired the mortgage in 2020, shows the date of acquisition.
