If provided at admission, this grace period will be annotated on the beneficiary's I-94 by Customs and Border Protection (CBP). The grace period of authorized stay but does not provide the beneficiary authorization to work beyond the petition validity period. The petitioner should keep the upper portion of this notice and a copy of the Form I-94, Departure Record, for each worker, to show that the employment or training of each of the workers included in the petition is authorized.
