Sales transactions are organized into sections according to term (long, short or undetermined) and covered status (covered or noncovered). Line 1a. Shows a brief description of the item or service for which amounts are being reported. For a corporation that had a reportable change in control or capital structure, this box may show the class of stock as C (common), P (preferred), or O (other).
