If "NONCOVERED" appears on line 5, this column may be blank. See the Instructions for

If "NONCOVERED" appears on line 5, this column may be blank. Line 2. The short-term and long-term boxes pertain to short-term gain or loss and long-term gain or loss. If the "Ordinary" box is checked, your security may be subject to special rules. Column 6. If the exercise of a non-compensatory option resulted in a sale of a security. indicates whether the amount in column 1d was adjusted for premium.

Column 7. If checked, you cannot take a loss on your tax return based on gross proceeds from a reportable change in control or capital structure reported in column 1d.
