Explanation of IL-1040 Changes

Need withholding verified

We changed your Illinois Income Tax withheld on Line 25 because we cannot verify the total amount you reported.

If you disagree with our changes, send us

- the Illinois copy of all paper W-2 and 1099 forms you received for the tax year and
- copies of the final paycheck stub received for the tax year from each of your employers or
- a letter from each employer or payer, on company letterhead, stating the amount of Illinois Income Tax withheld for this reporting period. We will not accept a letter from a tax preparer.

If you had business losses on your federal income tax return, send us a copy of your federal return, including all schedules. You must include your Schedule C, Profit or Loss from Business (Sole Proprietorship) and all documents you used to calculate the figures claimed on this schedule.

Late estimated payment penalty

We assessed a late-payment penalty for underpayment of estimated tax because you were required to make estimated payments and did not do so or did not pay the required amount of estimated payments by the payment due date.

This penalty is figured at increased rates based upon the number of days the payment is late. The penalty rates are

- 2 percent of any amount that is paid no later than 30 days after the due date, and
- 10 percent of any amount that is paid later than 30 days after the due date.

If your income was not received evenly throughout the year, you may be able to lower or eliminate the amount of your required installments by using the annualized income installment method in Step 6 of Form IL-2210, Computation of Penalties for Individuals.

Late-payment penalty

We assessed a late-payment penalty for unpaid tax because you did not pay the total tax you owed by the original due date of the return, even if you had an extension of time to file. This penalty is based on the amount required to be shown due on your return, minus any timely payments, timely credits, and the tax used in figuring the underpayment of estimated tax penalty.
