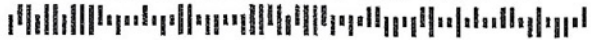

## What you need to do immediately

### Pay immediately

#### If you agree with the amount due and you're not working with an IRS representative

- Pay the amount due of \$581.80, to avoid additional interest and applicable penalty charges. If you recently made a payment that's not reflected in the amount you owe, subtract your recent payment from the amount due. If this results in a credit, we'll send you a refund check.
- Pay online or mail a check or money order with the attached payment stub.

**You can pay online now at [www.irs.gov/payments](http://www.irs.gov/payments).**

If we notified you that we suspended enforced collection on your account because it would create a financial hardship (meaning you would be unable to pay basic reasonable living expenses if we levied) and your financial situation has not changed, you don't need to do anything.

#### If you disagree with the amount due

Call us at 800-829-0922 to review your account with a representative. Be sure to have your account information available when you call.

We'll assume you agree with the information in this notice if we don't hear from you.

#### Bankruptcy

If you're a debtor in a bankruptcy case and the tax year for which you owe ended before the date of your bankruptcy petition, this notice is for your information only and you shouldn't pay at this time. It is not intended to seek payment outside of the bankruptcy process. If the tax year for which you owe ended after the date of the bankruptcy petition, please send us your payment as requested by this notice.

If you plan to mail a payment, consider the electronic options at [IRS.gov/payments](https://www.irs.gov/payments) first. It's free to pay from a bank account (Direct Pay) or the Electronic Federal Tax Payment System (EFTPS). You can also schedule payments and receive email notifications.

If you pay by check, money order, or cashier's check, make sure it's payable to the U.S. Treasury.

Can't pay it all now?

- Apply for a payment plan (installment agreement) at [IRS.gov/OPA](https://www.irs.gov/OPA)
- Consider an offer in compromise at [IRS.gov/OIC](https://www.irs.gov/OIC)
- Request a temporary collection delay at [IRS.gov/tempcollectiondelay](https://www.irs.gov/tempcollectiondelay)
