Personal Property taxes remaining unpaid after 60 calendar days from the original due date will

Once action is taken, a minimum \$30.00 collection fee may be incurred as well as any additional fees associated with the following actions that may be performed: DMV Stop preventing registrations and renewals, liens placed on wages or financial accounts, withholding of Virginia State income tax return, judgement in Loudoun County General District Court, and repossession of collateral.

If you are in Bankruptcy, this bill is being provided for informational purposes and per Federal Law, no collection actions will be pursued.

Per Code of VA, §58.1-3913, any payment received by the Loudoun County Treasurer's Office shall be applied to the most delinquent taxes first.
