

Form 1099-G. Certain Government Instructions for Recipient

This is important tax information and is being furnished to the Internal Revenue Service. If you are required to file a return, a negligence penalty or other sanction may be imposed on you if this income is taxable and the IRS determines that it has not been time the debt is discharged. However, there are exceptions reported. Box reference numbers are those used on Federal form 1099-G.

Box 2 - Shows refunds of Earnings Tax - Wage Earner you received. If there is any entry in this box, it may be taxable if you deducted the tax paid as an itemized deduction on your Federal income tax return. See the instructions for Form 1040 or 1040A for more information.
