Instructions for Recipient**

This is important tax information and is being furnished to the Internal Revenue Service. If you are required to file a return, a negligence penalty or other sanction may be imposed on you if this income is taxable and the IRS determines that it has not been reported. Box reference numbers are those used on Federal form 1099-G.

Box 5 - shows your indebtedness to a Federal government agency that is discharged this year as no longer collectible. This debt generally becomes taxable income to you at the time the debt is discharged. However, there are exceptions to this rule: for example, if you are insolvent or have declared bankruptcy. See Publication 908, Bankruptcy and Other Debt Cancellation, for additional information.

Box 2 - Shows refunds of Earnings Tax - Wage Earner you received. If there is any entry in this box, it may be taxable if you deducted the tax paid as an itemized deduction on your Federal income tax return. See the instructions for Form 1040 or 1040A for more information.

Box 8 - If this box is checked, the refund in Box 2 is attributable to an income tax that applies exclusively to income from a trade or business and is not a tax of general application. The amount, if taxable, should not be reported on page one of Form 1040, but should be reported on Schedule C or F (form 1040), as appropriate.

Box 3 - This identifies the tax year for which the refund shown in Box 2 was made.

Box 4 - Is for backup withholding. For example, persons not furnishing their taxpayer identifying number to the payer become subject to backup withholding at a 30% rate on certain payments. See Form W-9, Payer's Request for Taxpayer Identification Number and Certification, for information on backup withholding. Include this on your income tax return as tax withheld.
