Box 1e. Shows the cost or other basis of securities were acquired through the exercise of a noncompensatory option granted or acquired on or after January 1, 2014, the basis has been adjusted to reflect your option premium. If the securities were acquired through the exercise of a noncompensatory option granted or acquired through the exercise of a noncompensatory option premium. If the securities were acquired through the exercise of a noncompensatory option granted or acquired through the exercise of a compensatory option, the basis has not been adjusted to include any amount related to the option that was reported to you on a Form W-2.
