Sales transactions are organized into sections according to term (long, short or undetermined) and covered status (covered or noncovered). **Line 2.** The short-term and long-term boxes pertain to short-term gain or loss and long-term gain or loss. If the "Ordinary" box is checked, your security may be subject to special rules.
