Sales transactions are organized into sections according to term (long, short or undetermined) and covered status (covered or noncovered). Line 1f. Shows the amount of accrued market discount. For details on market discount, see the Schedule D (Form 1040 or 1040-SR) instructions, the Instructions for Form 8949, and Pub. 550. If box 5 is checked, box 1f may be blank.
