Narrative

On October 23, 2021 I, Ofc. Reyes #153 was dispatched to 5675 Jimmy Carter Blvd (Global Mall) in reference to an entering auto.

Upon arrival I met with the complaint Lakshmi Mounika 993) and she stated that she got out of her vehicle (Silver Hyundai Accent GA#RVB6323) and went in the mall around 4:30PM. When she returned around 5:21PM she noticed that her back passenger side window was busted. Ms. Mounika stated that she looked in her vehicle and noticed several items missing from inside. She had 2 book bags (\$60 total for 2) missing along with 3 laptops (\$1,400 total for 3), 1 IPad (\$400 total for 1) and 2 fitbit watches (\$500 total for both). Ms. Mounika was able to provide a serial number for the IPad and 2 laptops(F6QD201BLMPF), which was entered in to GCIC/NCIC as stolen by communications officer Stephens at 5:35PM. Ms. Mounika was unable to provide serial numbers for the 3 laptops that were taken.

Upon entering all information I was able to observe 3 cameras in the area. I then went to the security room to look at footage and at 4:44PM I was able to observe a Gray Jeep Wrangler drive around Ms. Mounika's vehicle. Around 4:49PM a black male suspect in a short sleeve t-shirt gets out of the passenger door, smashes the window open and take items from the vehicle. The vehicle then drives out at 4:50PM through the back side of the mall towards Goshen Springs. I then followed up with the information given based on video footage of the suspect vehicle and was able to find a match on FLOCK cameras. The vehicle had a Ga. tag of (CRR6391) which returned back on GCIC/NCIC as a Gray 2021 Jeep Wrangler and the registered owner as Naseer Hairs

Pictures of the victim's vehicle were taken and picture of the suspect vehicle were taken as well. Ms. Mounika was given a case card and was advised on how to obtain a copy of the report.

A warrant was obtained for Mr. Naseer's arrest for Entering Automobile or other Motor Vehicle with Intent to Commit Theft or Felony (21W16081).
