Sales transactions are organized into sections according to term (long, short or undetermined) and covered status (covered or noncovered). **Line 13.** Shows the cash you received, the fair market value of any property or services you received, and the fair market value of any trade credits or scrip credited to your account by a barter exchange. See Pub. 525.

**Lines 14-16.** Show state(s)/local income tax information.
