Sales transactions are organized into sections according to term (long, short or undetermined) and covered status (covered or noncovered). May also show the aggregate amount of cash and the fair market value of any stock or other property received in a reportable change in control or capital structure arising from the corporate transfer of property to a foreign corporation. Losses on forward contracts or non-Section 1256 option contracts are shown in parentheses. This box does not include proceeds from regulated futures contracts or Section 1256 option contracts. Line 1e. Shows the cost or other basis of securities sold.
