THE PARTICIPANT HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE THE CITY OF FREMONT, ITS EMPLOYEES, OFFICERS AND AGENTS (hereinafter referred to as "releases") from all liability to the participant, his or her personal representatives, assigns, heirs, and next of kin, for any loss, damage, or claim therefore on account of injury to the person, participant's family member, or property of the participant, whether caused by any negligent act or omission of the releases or otherwise, while the participant or participant's family member is participating in a City activity or using any City facilities in connection with the activity. Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The Novel Coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and health agencies recommend social distancing and have restricted the gathering of groups.

While COVID-19 can cause mild symptoms in some individuals, it can lead to severe illness and even death in others. Adults over age 65 and people of any age with serious underlying medical conditions as defined by the CDC, may be a higher risk for more serious complications from COVID-19.

Attending recreation programs could increase your risk and your child(ren)'s risk of contracting COVID-19. The City of Fremont Community Services Department has put in place preventative measures to reduce the spread of COVID-19 consistent with the Alameda County Public Health Department Guidelines; however, the City cannot guarantee that you, your child(ren) or other program participants will not become infected with COVID-19. The City is taking precautions to prevent the spread of COVID-19 but these precautions are not guarantees that any participants will not contract COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the City of Fremont recreation programs and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 by attending the City of Fremont recreation programs may result from the actions, omissions, or negligence of myself and others, including, but not limited to, City employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s participation in recreation programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the City, its employees, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the City, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any City of Fremont recreation program.

REFUND/TRANSFER POLICY: Refunds are allowed if requested up to seven (7) calendar days prior to the start of the activity. A \$10 per class withdrawal fee will be deducted from your refund. Please allow up to four weeks for receipt of refund by check. Transfers are allowed up to seven (7) calendar days prior to the start of the class. There is no charge for this service. Request for refunds and transfer must be received in writing.

Cancellations. We reserve the right to cancel an activity for any reasonable cause. Should this happen, you will be refunded in full or you may transfer to any open activity.
