Important Updates: Fifth Third Business Banking Deposit Accounts

To make our Business Banking products and services easier to understand, we are making some changes. Please read the details below so you know how these upcoming changes may affect you.

Fewer fees and simpler pricing

Beginning January 1, 2023, all Business Banking accounts will no longer be assessed a Negative Collected fee.

- Although the fee will no longer be assessed as of January 1, you may continue to see transaction activity from December on the January statement.
- If you have a Commercial account, this fee will continue to be assessed as "Uncollected Balance Usage Fee."

Beginning February 1, 2023, Fifth Third Business Standard Checking Account® becomes Fifth Third Business Checking Account®, AND we will no longer assess the Monthly Service Charge on this account type. No minimum balance requirement or other activity requirements to avoid a Monthly Service Charge.

Beginning March 1, 2023, the fee for a cashier's check will decrease from \$10.75 to \$10.00.

Additional changes

Beginning February 1, 2023, the fee for U.S. transactions initiated at Non-Fifth Third ATMs⁶ will be \$3.00 per transaction. Transactions include balance inquiries, transfers, cash withdrawals, and purchases made at an ATM. Other ATM network owners may also assess a usage fee. We will discontinue any refunds of this fee at that time.

Beginning February 1, 2023, a \$2 fee will apply in order to receive check images mailed with your monthly statements. You can view the most recent 24 months' statements through online banking at no charge.
