Computershare and other brokers/agents are required to provide additional information to you, and to the IRS, when you sell securities. If we are reporting more than one tax event on this Form 1099-B you will have an additional summary line for each such event.

PLEASE NOTE: Computershare will not report cost basis of noncovered shares to the IRS, but you are still required to report gain/loss details on your income tax return. You may be required to recognize gain from the receipt of cash, stock, or other property that was exchanged for the corporation's stock. For a corporation that had a reportable change in control or capital structure, this box may show the class of stock as C (common), P (preferred), or O (other).

Box 1b. This box may be blank if box 5 is checked or if the securities sold were acquired on a variety of dates. For short sales, the date shown is the date you acquired the security delivered to close the short sale. **Box 1c.** Shows the trade date of the sale or exchange.

Box 1d. Shows the cash proceeds, reduced by any commissions or transfer taxes related to the sale, for transactions involving stocks, debt, commodities, forward contracts, non-Section 1256 option contracts, or securities futures contracts. May show the proceeds from the disposition of your interest(s) in a widely held fixed investment trust. Losses on forward contracts or non-Section 1256 option contracts are shown in parentheses. This box does not include proceeds from regulated futures contracts or Section 1256 option contracts. Box 1e. Shows the cost or other basis of securities sold. If the securities were acquired through the exercise of a non-compensatory option granted or acquired on or after January 1, 2014, the basis has been adjusted to reflect your option premium. If the securities were acquired through the exercise of a non-compensatory option granted or acquired before January 1, 2014, your broker is permitted, but not required, to adjust the basis to reflect your option premium.
