

Sales transactions are organized into sections according to term (long, short or undetermined) and covered status (covered or noncovered). Some tax lots may have notations in the column of Additional Information because they require special treatment on your tax returns. Sales of securities such as Contingent Payment Debt Instruments (CPDI) are marked as "Ordinary" because gains and losses on these instruments generally do not qualify as short- or long-term capital transactions. Line 2. The short-term and long-term lines pertain to short-term gain or loss and long-term gain or loss.
