To file your 2021 tax return, simply follow these instructions:

Step 1. Sign and date the return

Step 2. Assemble what you need to mail

In addition to the forms the program will print for you, you must review the items below for any other documents required by your state.

- enclose your check or money order with the return.
- review your return carefully before mailing. Make sure your social security number(s) is correct.
- assemble your return with the Form 760CG on top. Do not use staples.
- if you had earnings reported on W2s or 1099s, your return will include a Schedule INC/CG. The Sch. INC/CG MUST be included with your return. Failure to submit the Sch. INC/CG will delay the issuance of your refund check, if applicable.
- because we have prepared your return using certified software that provides a Schedule INC/CG, Virginia no longer requires submission of W2s or 1099s. The Sch. INC/CG replaces the requirement for submitting W2s and 1099s. You are advised to retain copies of your W2s and 1099s with your records in the event your return is audited.
 - do not submit this instruction sheet with your return. Retain with your records.
 - enclose a copy of your federal Schedule E with your Virginia return.
 - enclose a copy of your federal Form 4562 with your Virginia return.

To print your federal return or the federal forms listed above:

- 1. Click the Print button in the top-right corner of the program.
- 2. In the Select What to Print box select federal.
- 3. Choose the Official Return or the Selected Forms radio button.
- 4. For Selected Forms, select each form you would like to print in the box below.
- 5. Then click Print.

Step 3. Pay the balance due on your taxes

Make your check or money order for \$6378 payable to "Virginia Department of Taxation". Don't send cash.

Write the following on your check or money order:

- write your social security number(s), phone number and "2021 Income Tax" on the check or money order.

Step 4. Mail the return

For Refund returns, mail to: Virginia Department of Taxation P.O. Box 1498 Richmond, VA 23218-1498

For Tax Due returns, mail to: Virginia Department of Taxation P.O. Box 760 Richmond, VA 23218-0760

We recommend that you use one of these methods to send your return. Retain the proof of mailing to avoid a late filing penalty:

U.S. Postal Service certified mail.

(if not mailing to a P.O. Box, you may also use one of the following)

- DHL Express, Express 9:00, Express 10:30, Express 12:00, Express Worldwide, Express Envelope, Import Express 10:30, Import Express 12:00, and Import Express Worldwide.
- FedEx First Overnight, Priority Overnight, Standard Overnight, 2 Day, International Next Flight Out, International Priority, International First, or International Economy.
- UPS Next Day Air Early A.M., Next Day Air, Next Day Air Saver, 2nd Day Air, 2nd Day Air A.M., Worldwide Express Plus, or Worldwide Express.

Step 5. Keep a copy

Print a second copy of the return for your records. We recommend that you also print and retain these supporting forms, which don't need to be sent to the state:
