 Individual Income Tax Return



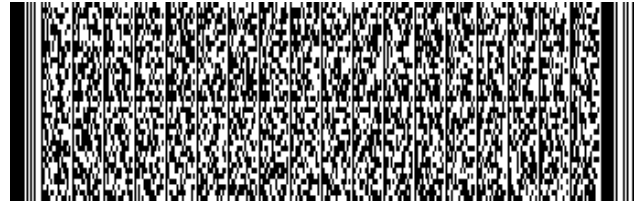
