Box 12. The following list explains the codes shown in box 12. You may need this information to complete your tax return. However, if you were at least age 50 in 2023, your employer may have allowed an additional deterral of up to \$7.500 (\$3.00 for section 401(k)(11) and 408(p) SIMPLE plans). For code G, the limit on elective deferrals may be higher for the last 3 years before you reach retirement age. Contact your plan administrator for more information. Box 14. Railroad employers use this box to report railroad retirement (RRTA) compensation, Tier 1 tax, Tier 2 tax, Medicare tax, and Additional Medicare Tax Include tips reported by the employee to the employer in railroad retirement (RRTA) compensation.

Note: Keep Copy C of Form W-2 for at least 3 years after the due date for filing your income tax return. However, to help protect your social security benefits, keep Copy.
