Sales transactions are organized into sections according to term (long, short or undetermined) and covered status (covered or noncovered). Line 1e. Shows the cost or other basis of securities sold. Line 2. The short-term and long-term boxes pertain to short-term gain or loss and long-term gain or loss. If the "Ordinary" box is checked, your security may be subject to special rules.
