- Box 1. Enter this amount on the wages line of your tax return.
- Box 2. Enter this amount on the federal income tax withheld line of your tax return.
- **Box 5.** You may be required to report this amount on Form 8959. See the Form 1040 Instructions to determine if you are required to complete Form 8959.
- **Box 6.** This amount includes the 1.45% Medicare tax withheld on all Medicare wages and tips shown in box 5, as well as the 0.9% Additional Medicare Tax on any of those Medicare wages and tips above \$200.000
- **Box 8.** This amount is **not** included in box 1, 3, 5, or 7. For information on how to report tips on your tax return, See the Form 1040 Instructions. You must file Form 4137 with your income tax return to report at least the allocated tip amount
- unless you can prove with adequate records that you received a smaller amount. By our have records that show the actual amount of tips you received, report that amount or if it is more reless than the allocated tips. Use Form 4137 to figure the social security and Medicare tax owed on tips you didn t report to your employer. Enter this amount on the wages line of your tax return. By filing Form 4137, your social security tips will be credited to your social security record (used to figure your benefits).

Do you have to file? Refer to the Forms 1040 instructions to determine if you are required to file a tax return. Even if you don t have to file a tax return, you may be eligible for a refund if box 2 shows an amount or if you are eligible for any credit.

Earned income credit (EIC). You may be able to take the EIC for 2023 if your adjusted gross income (AGI) is less than a certain amount. The amount of the credit is based on income and family size. Workers without children could qualify for a smaller credit. You and any qualifying children must have valid social security numbers (SSNS). You can take the EIC if your investment income is more than the specified amount for 2023 or if income is earned for services provided while you were an immate at a penal institution. For 2023 income limits and more information, visit www.irs.gov/EITC. See also Pub. 596. Any EIC that is more than your tax liability is refunded to you, but only if you file a tax return.

Employee's social security number (SSN). For your protection, this form may show only the last four digits of your SSN. However, your employer has reported your complete SSN to the IRS and the Social Security Administration (SSA)
