You received this form instead of Form W-2 because the payer did and Medicare taxes are withheld, you should make estimated tax not consider you an employee and did not withhold income tax or social security and Medicare tax

If you believe you are an employee and cannot get the payer to correct this form, report the amount shown in box 1 on the line for "Wages, salaries, tips, etc." of Form 1040, 1040-SR, or 1040-NR, You must also complete Form 8919 and attach it to your return. If you are not an employee but the amount in box 1 is not selfemployment (SE) income (for example, it is income from a the "Other income" line (on Schedule 1 (Form 1040)).
