

Federal Tax Credit Eligibility Report

New Vehicles. Dealers who sell vehicles that are eligible for a *new* clean vehicle credit under Internal Revenue Code (“*IRC*”) Section 30D must furnish a report to the buyer at the time of sale and then to Internal Revenue Service (“*IRS*”) for those vehicles to be eligible for a credit under IRC Section 30D.

Used Vehicles. Dealers who sell vehicles eligible for a *used* (previously owned) vehicle credit under IRC Section 25E must furnish a report to the buyer at the time of sale and then to IRS for those vehicles to be eligible for a credit under IRC Section 25E.


