Sales transactions are organized into sections according to term (long, short or undetermined) and covered status (covered or noncovered). Line 1e. Shows the cost or other basis of securities sold. If the securities were acquired through the exercise of a noncompensatory option granted or acquired on or after January 1, 2014, the basis has been adjusted to reflect your option premium.
