### Instructions for Recipient

You received this form instead of Form W-2 because the payer did not consider you an employee and did not withhold income tax or social security and Medicare tax.

If you believe you are an employee and cannot get the payer to correct this form, report the amount shown in box 1 on the line for "Wages, salaries, tips, etc." of Form 1040, 1040-SR, or 1040-NR. You must also complete Form 8919 and attach it to your return. For more information, see Pub. 1779, Independent Contractor or Employee.

If you are not an employee but the amount in box 1 is not self-employment (SE) income (for example, it is income from a sporadic activity or a hobby), report the amount shown in box 1 on the "Other income" line (on Schedule 1 (Form 1040)).

**Recipient's taxpayer identification number (TIN).** For your protection, this form may show only the last four digits of your TIN (social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN)). However, the issuer has reported your complete TIN to the IRS.

**Account number.** May show an account or other unique number the payer assigned to distinguish your account.

**Box 1.** Shows nonemployee compensation. If the amount in this box is SE income, report it on Schedule C or F (Form 1040) if a sole proprietor, or on Form 1065 and Schedule K-1 (Form 1065) if a partnership, and the recipient/partner completes Schedule SE (Form 1040).

**Note:** If you are receiving payments on which no income, social security, and Medicare taxes are withheld, you should make estimated tax payments. See Form 1040-ES (or Form 1040-ES (NR)). Individuals must report these amounts as explained in these box 1 instructions. Corporations, fiduciaries, and partnerships must report these amounts on the appropriate line of their tax returns.

**Box 2.** If checked, consumer products totaling \$5,000 or more were sold to you for resale, on a buy-sell, a deposit-commission, or other basis. Generally, report any income from your sale of these products on Schedule C (Form 1040).

**Box 3.** Reserved for future use.

## Form 1099-NEC: Nonemployee Compensation

What's a 1099-NEC?

Form 1099-NEC is used to report nonemployee compensation (e.g. service income) to U.S. payees.

If you are a U.S. payee and received nonemployee compensation totaling \$600 or more, Amazon is required to provide you a 1099-NEC form as well as report these amounts to the IRS.

Will I also get a 1099-MISC?

If you are a U.S. payee and earn income reportable on Form 1099-MISC (e.g. royalty or rent income) by participating in one or more Amazon programs, you may be eligible to receive a 1099-MISC if you meet the reporting threshold (\$10 for royalties and \$600 for all other payments). What's represented in the table?

Your form is a summary of the payments you received from Amazon in 2023. This table is for information purposes only and is not provided to the IRS.

How are the amounts on the form calculated?

For a detailed report of all your orders, log into your Vine account and follow these steps: 1. Click on 'Account' tab 2. Under the 'Vine Tax Information' section, select the year for which you'd like to view the report and click on 'Download Itemized Report'.

Do you need to update your name, address, or other tax information?

Amazon cannot reissue a tax form for previous years due to an updated name, address or Tax ID. To ensure your information is updated for subsequent forms, retake the Tax Interview.

What is gross income?

For Vine, your gross income is defined as noncash compensation or the estimated total fair market value (FMV) which is calculated based on a variety of factors, including information provided by the manufacturer. The current price is only one of the components taken into account when calculating the FMV of an item which may be different from the current price listed on Amazon.com. There are certain categories where we have a set FMV. For example, third-party household goods such as grocery, beauty, and pet foods will be generally valued at \$0. Books, including Advanced Reader Copies, will be valued at 99 cents. We cannot make adjustments to this value; please know that if you order this item you will be responsible for paying taxes associated with the FMV shown.
