Tax Billing – Regular real estate taxes are billed in two equal installments. The first half is due July 15, and the second half is due December 5. If either date falls on a weekend, the due date is the next business day. Included with most real estate tax bills are storm water management and solid waste fees.

Some properties are assessed a supplemental tax; typically for new homes or properties where an improvement has been completed during the year. Supplemental taxes are billed as single installments and are due as stated on the bill. A prorated storm water management and solid waste fee might be included on the supplemental tax bill.

Most property owners pay their real estate taxes through a mortgage company, the County bills and collects real estate property tax payments directly from the mortgage services companies. On occasion, the billing information on file is incorrect, and a bill is mistakenly mailed to a property owner. If you receive a real estate tax bill and your escrow property taxes are handled by a mortgage company, you should contact your mortgage company immediately. Your mortgage company will tell you the correct procedure for having the mortgage company make the payment directly to the County on your behalf.

Payments – To be on time, mailed payments must be postmarked on or before midnight of the original due date. Payments made online must be completed on or before the due date.

Penalty – If taxes are not paid in full by the due date, a late payment penalty of 10% will be assessed on the unpaid tax balance.

Interest – Interest at the rate of 10% per annum is added to any unpaid balance beginning the first day of the month following the original due date.

Return Fee – A \$50 service fee is added to your account for each check or electronic payment authorization not honored.

Tax Relief Programs

1) Elderly persons or persons who are permanently and totally disabled that meet income and net worth eligibility requirements may qualify for relief from all or part of real estate taxes and personal property taxes on one vehicle.

2) U.S. Veterans with a 100% service-connected, permanent, and total disability, surviving spouses of deceased disabled veterans, and surviving spouses of service members killed in action or certain persons killed in the line of duty may be eligible for real estate tax relief regardless of income or net worth.
