Note: If line 9 is zero, **stop**; you can't take this credit.

- Multiply line 7 by line 9 **10** 200.
- Limitation based on tax liability. Enter the amount from the Credit Limit Worksheet in the instructions **11** 4,285.
- Credit for qualified retirement savings contributions.** Enter the **smaller** of line 10 or line 11 here and on Schedule 3 (Form 1040), line 4 **12** 200.

* See Pub. 590-A for the amount to enter if you claim any exclusion or deduction for foreign earned income, foreign housing, or income from Puerto Rico or for bona fide residents of American Samoa.
