  - Make the subject line: Audit Defense Redemption.
  - Include your name, phone number, and the best time to reach you (within their business hours).
- 2. You'll have to provide some personal info to get started, as well as:
  - Your Defense code: CA22-U77Q
  - The tax return year: 2018
  - Whether it's a federal (IRS) or state audit
- 3. You'll get an email with a secure link to upload your tax return and the audit notice you received.

### **Policy Details**

Your Audit Defense expires one year after the 2018 tax deadline or your e-file date (whichever is later). If you're not sure when you e-filed, you can find the date on your Credit Karma Tax dashboard.
