Attached is a copy of your 2017 Relocation Tax Report. This report summarizes the relocation expenses and funds that were either directly paid to you or paid to a vendor on your behalf. This report will be a useful tool for the preparation of your Federal 3903 Moving Expenses form and your 2017 Federal tax return.

Items included in your Form W-2:

- * Expenses that were reimbursed to you and are taxable (per USA IRS regulations).
- * Amounts that Amazon.com paid on your behalf, including the income tax liability associated with qualified expenses and reimbursements.
- * Expenses that are excludable from income taxes but were paid directly to you. These expenses are shown on your W-2 in Box 12, which is preceded by the letter "P" (Excludable moving expense reimbursements paid directly to employee).

Please note: Expenses that are considered excludable from income taxes and were paid to a third party are not included in your W-2.

The Relocation Tax Report is provided to assist you with filing your U.S. Federal and U.S. State tax returns. If you have any questions or difficulty with preparing your personal income tax forms, please consult a professional tax adviser. If your tax preparation is not based in the U.S., you should still provide this information to your tax preparer.
