IRS Form 990-T is required to be filed by April 15 each year, when applicable. If you do not hold MLPs or LPs in your IRA going forward, this filing would not be applicable to you. Effective beginning for 2019 calendar year tax reporting and in accordance with the IRA Custodial Agreement, if a Form 990-T filing is required a \$75 IRS 990-T UBTI Tax Return Filing fee will apply.
