Car Tax Relief has been capped by the Commonwealth of Virginia. For 2018, the relative value of the state car tax subsidy on personal use vehicles in Fairfax County is 60% of the car tax levy on the first \$20,000 of assessed value. The state subsidy for Car Tax Relief, if applicable, is shown on the tax bill and taxpayers must pay the remainder.

Penalties: Late filing penalty for the late registration of vehicles with Fairfax County shall be 10% or \$10.00, whichever is greater, not to exceed amount of tax due. "No Plate Tax" (\$100 tax assessed annually, plus an additional \$250 annual penalty) on certain vehicles without Virginia license plates. Late payment penalty of 10%, plus interest, if not paid in full by October 5, 2018. Penalty will increase to 25% on balances that remain unpaid as of November 6, 2018.

Pay by 10/05/18 to avoid penalties & collection actions.
