



2018 CRP, Certificate of Rent Paid

Eligible renters may receive a refund based on property taxes paid on their principal place of residence in Minnesota and their income. Renters will need this CRP, Certificate of Rent Paid, to apply for a property tax refund (see eligibility requirements below).

The landlord is required to give each renter a completed CRP no later than January 31, 2019.

Roommates: The landlord is required to give each unmarried renter living in a unit a separate CRP showing that each roommate paid an equal portion of the rent, regardless of the portion actually paid or whose names are on the lease.
